Content and Objectives of the Programme

The degree subject Ancient Near Eastern Languages and Cultures is offered by the Faculty of Arts of JMU in the framework of a Master's programme combining two majors of equal weighting; the degree subject Ancient Near Eastern Languages and Cultures has a research focus. Students who write their Master's thesis in the degree subject Ancient Near Eastern Languages and Cultures are awarded a Master of Arts (MA) degree.

Graduates from Ancient Near Eastern Languages and Cultures

- have gained a thorough familiarity with selected branches of ancient Near Eastern studies, the
 different epochs in the history of the ancient Near East and the characteristics of the most
 important ancient Near Eastern cultures,
- have learned the research methods needed to undertake independent and critical research in the field of ancient Near Eastern studies and/or pursue doctoral studies in the discipline,
- have developed an in-depth knowledge of the Akkadian and Sumerian (optionally also Hittite) languages in different historical stages and dialects of these languages,
- have developed an advanced knowledge of the Mesopotamian cuneiform script,
- have developed a knowledge of some additional ancient Near Eastern languages and the scripts used to write them (optional),
- have developed a deeper and differentiated understanding of the typical thought patterns of the ancient Near Eastern cultures.
