Content and Objectives of the Programme

The subject of art is offered by the Faculty of Human Sciences at JMU. It can be studied as part of the teaching qualification at middle schools and as part of the teaching qualification for special education as one of three didactics subjects within the didactics of a subject group at the middle school (Section 37 Paragraphs 3 and 4 LPO I).

By studying art education, the subject-specific fundamentals are imparted for later professional use as a teacher at middle schools or as a teacher for special education. The aim of the course is to acquire relevant technical and didactic knowledge that enables students to initiate and design mediation, learning and educational processes related to the subject-specific learning content.

Contents		
<p>Encountering original works of art enables direct engagement that goes beyond reproduced images. Students analyse the works from an art history perspective and reflect on the methodological and didactic aspects of this encounter. This includes the perception of materiality, scale, colour effect, surface structure and spatial presence, which can only be experienced in the original, as well as consideration of context, provenance and exhibition design.</p> <p>In addition, organisational aspects of an encounter with the original, such as planning and conducting excursions, logistics, temporal and spatial conditions, integration of groups and mediation structures, are systematically addressed. Students learn to design excursions in such a way that both the analytical work on the works and the mediation of art-historical and didactic content can be carried out efficiently and purposefully.</p> <p>A special focus is placed on the specifics of encountering the original: direct perception provides insights into dimensions, richness of detail, material properties and craft techniques that can only be grasped to a limited extent in reproductions. Students reflect on how these immediate impressions influence the interpretation, analysis and methodological communication of works of art. In addition, consideration is given to how the perceptual experience can be didactically prepared and communicated to different target groups in order to promote sustainable learning.</p> <p>Overall, the study of originals combines art-historical analysis, methodological reflection and practical communication skills, and trains students in the independent planning, implementation and didactic realisation of encounters with works of art.</p>		
Intended learning outcomes		
<p>Students develop the ability to analyse original works of art precisely, to perceive their materiality, colour effect, scale, surface structure and spatial presence in a differentiated manner, and to incorporate these findings into art-historical interpretations. They are able to independently plan and carry out organisational aspects of excursions and encounters with original works, including consideration of temporal, spatial and logistical conditions as well as the structuring of educational content appropriate to the target group. In addition, they acquire the ability to reflect on methodological and didactic issues, to recognise the specifics of encounters with originals, and to prepare the perceptual experiences for different target groups in a didactic manner. Students thus combine analytical, organisational and methodological-didactic skills, enabling them to produce scientifically sound interpretations and transfer these findings into teaching and communication situations in a practical manner.</p>

Preparation of a written Hausarbeit (thesis) in accordance with the provisions of Section 29 LPO I (examination regulations for teaching-degree programmes) is a prerequisite for teaching degree students to be admitted to the Erste Staatsprüfung (First State Examination). In accordance with the provisions of Section 29 LPO I, students studying for a teaching degree Mittelschule may write this thesis in the subject Didaktik einer Fächergruppe der Mittelschule (Didactics of a Group of Subjects of Mittelschule), in the subject they selected as Unterrichtsfach (subject studied with a focus on the scientific discipline) or in the subject Erziehungswissenschaften (Educational Science). Pursuant to Section 29 Subsection 1 Sentence 2 LPO I, students may also choose to write an interdisciplinary thesis.

The written term paper is an independent written presentation of the results of the student's own research into a subject from the field of art education. It must be demonstrated that the chosen methods have been considered, selected appropriately for the subject matter and applied correctly. Knowledge of the literature must be taken into account, terms must be used correctly and the results must be categorised in the context of the literature. An error-free presentation in an appropriate manner is expected.
