Learning Outcomes

Der Studiengang Bachelor Pflegewissenschaft fokussiert auf die evidenzbasierte klinische Pflege aller Altersstufen sowohl in akuten als auch dauerhaften Versorgungssituationen im stationären und ambulanten Setting. Vermittelt werden fachliche und personale Kompetenzen, um auf wissenschaftlicher Grundlage eine selbstständige umfassende und prozessorientierte Pflege durchzuführen sowie eigenverantwortlich und selbstständig erweiterte heilkundliche Tätigkeiten in den Bereichen diabetische Stoffwechsellage, chronische Wunden und Demenz zu übernehmen (gem. §37 Abs. 2 PflBG).

Der Studiengang befähigt zur Berufsausübung als akademisch qualifizierte Pflegefachperson in der direkten Versorgung von zu pflegenden Menschen. Die Absolventinnen und Absolventen des Bachelorstudiengangs werden qualifiziert für folgende Tätigkeitsbereiche:

1. Klinische Patientenversorgung in allen Sektoren und bei komplexen Problemlagen,
2. Praxis- und Qualitätsentwicklung,
3. Spezielle Tätigkeitsbereiche in der Gesundheitsversorgung (z. B. Pflegeberatung)
4. Wissenschaftliche Forschungsassistenten

Der Studiengang ist als Vollzeitstudium angelegt mit einer Regelstudienzeit von 7 Semestern mit jeweils 30 ECTS pro Semester. Die Ausgestaltung des Studiums setzt die Bestimmungen des Pflegeberufgesetzes (PflBG) und der Ausbildungs- und Prüfungsverordnung für die Pflegeberufe (PflAPrV) um und richtet sich daher maßgeblich an deren Anforderungen aus. Im Studium absolvieren Studierende sowohl theoretische Studienanteile an der Universität als auch praktische Studienanteile in Gesundheits- und Pflegeeinrichtungen. Umfang und Einsatzbereiche der zu erbringenden Praxiseinsätze richten sich nach den gesetzlichen Vorgaben. Einsatzbereiche sind die stationäre Akut- und Langzeitpflege, die ambulante Akut- und Langzeitpflege, die pädiatrische und psychiatrische Versorgung sowie ein frei wählbarer Bereich im Wahlpflichtpraxiseinsatz (z. B. Pflegeberatung). Die Studierenden wählen zudem einen praktischen Vertiefungseinsatz (z. B. Pädiatrie, Akutpflege), in dem sie dann auch das praktische Staatsexamen ablegen.

Für die praktischen Studienanteile wird ein Träger-Kooperationsvertrag geschlossen. Ein Träger ist das Universitätsklinikum Würzburg. Die Trägereinrichtung des praktischen Teils der hochschulischen Pflegeausbildung schließt mit den Studierenden einen vergüteten Ausbildungsvertrag. Der Träger übernimmt die Verantwortung für die Organisation und Durchführung aller Praxiseinsätze einschließlich der Praxisanleitung. Über Unterverträge mit weiteren Praxiseinrichtungen, die in Abstimmung mit der Universität geschlossen werden, sichert die jeweilige Trägereinrichtung der praktischen hochschulischen Ausbildung die Sicherstellung der Praxiseinsätze in Einsatzbereichen, die nicht hausintern abgedeckt werden können (z. B. Pflegeheime, ambulante Pflegedienste). Die Gesamtverantwortung für die Koordination der theoretischen und praktischen Lehrveranstaltungen mit den Praxiseinsätzen sowie die Durchführung der Praxisbegleitung verbleibt bei der Universität.

Die Qualifikationsziele des Studiengangs richten sich nach den Ausbildungszielen der hochschulischen Pflegeausbildung des Pflegeberufgesetzes (§37 PflBG). So erwerben die Absolventinnen und Absolventen die im Pflegeberufgesetz beschriebenen Kompetenzen der beruflichen Pflegeausbildung und werden darüber hinaus insbesondere befähigt

- „1. zur Steuerung und Gestaltung hochkomplexer Pflegeprozesse auf der Grundlage wissenschaftsbasierter oder wissenschaftsorientierter Entscheidungen,
2. vertieftes Wissen über Grundlagen der Pflegewissenschaft, des gesellschaftlich-institutionellen Rahmens des pflegerischen Handelns sowie des normativ-institutionellen Systems der Versorgung anzuwen-

den und die Weiterentwicklung der gesundheitlichen und pflegerischen Versorgung dadurch maßgeblich mitzugestalten,

3. sich Forschungsgebiete der professionellen Pflege auf dem neuesten Stand der gesicherten Erkenntnisse erschließen und forschungsgestützte Problemlösungen wie auch neue Technologien in das berufliche Handeln übertragen zu können sowie berufsbezogene Fort- und Weiterbildungsbedarfe zu erkennen,
4. sich kritisch-reflexiv und analytisch sowohl mit theoretischem als auch praktischem Wissen auseinandersetzen und wissenschaftsbasiert innovative Lösungsansätze zur Verbesserung im eigenen beruflichen Handlungsfeld entwickeln und implementieren zu können,
5. an der Entwicklung von Qualitätsmanagementkonzepten, Leitlinien und Expertenstandards mitzuwirken,
6. zur selbständigen und eigenverantwortlichen Übernahme von erweiterten heilkundlichen Tätigkeiten in den [oben] genannten Bereichen in Pflege- und Therapieprozessen auch bei hochkomplexen Pflegebedarfen von Menschen aller Altersstufen unter Einbezug von deren Bezugspersonen und in Zusammenarbeit mit den behandelnden Ärztinnen und Ärzten,
7. zur Integration der eigenverantwortlich und selbständig ausgeübten erweiterten heilkundlichen Aufgaben in den [oben] genannten Bereichen in den Pflege- und Therapieprozess aus einer pflegerischen Perspektive sowie dazu, die so gewonnenen Erkenntnisse im interprofessionellen Team argumentativ zu vertreten und die subjektiven Vorstellungen zu diesen Aufgaben zu reflektieren,
8. zur Verabreichung von Infusionstherapie und Injektionen sowie zur Verordnung von und Versorgung mit Medizinprodukten und Hilfsmitteln in den in [oben] genannten Bereichen und
9. zur Auseinandersetzung mit einem professionellen Berufs- und Rollenverständnis in Bezug auf die selbständige und eigenverantwortliche Ausübung erweiterter heilkundlicher Tätigkeiten sowie den damit zusammenhängenden fachlichen, wirtschaftlichen, rechtlichen und ethischen Fragestellungen, die sich aus dem Anspruch einer prozesshaften Bearbeitung und einer am zu pflegenden Menschen ausgerichteten Pflege ergeben.“ (§37, Abs. 3)

 - d) Analyse, Evaluation, Sicherung und Entwicklung der Qualität der Pflege,
 - e) Bedarfserhebung und Durchführung präventiver und gesundheitsfördernder Maßnahmen,
 - f) Beratung, Anleitung und Unterstützung von zu pflegenden Menschen bei der individuellen Auseinandersetzung mit Gesundheit und Krankheit sowie bei der Erhaltung und Stärkung der eigenständigen Lebensführung und Alltagskompetenz unter Einbeziehung ihrer sozialen Bezugspersonen,
 - g) Erhaltung, Wiederherstellung, Förderung, Aktivierung und Stabilisierung individueller Fähigkeiten der zu pflegenden Menschen insbesondere im Rahmen von Rehabilitationskonzepten sowie die Pflege und Betreuung bei Einschränkungen der kognitiven Fähigkeiten,
 - h) Einleitung lebenserhaltender Sofortmaßnahmen bis zum Eintreffen der Ärztin oder des Arztes und Durchführung von Maßnahmen in Krisen- und Katastrophensituationen,
 - i) Anleitung, Beratung und Unterstützung von anderen Berufsgruppen und Ehrenamtlichen in den jeweiligen Pflegekontexten sowie Mitwirkung an der praktischen Ausbildung von Angehörigen von Gesundheitsberufen,
2. ärztlich angeordnete Maßnahmen eigenständig durchzuführen, insbesondere Maßnahmen der medizinischen Diagnostik, Therapie oder Rehabilitation,

3. interdisziplinär mit anderen Berufsgruppen fachlich zu kommunizieren und effektiv zusammenzuarbeiten und dabei individuelle, multidisziplinäre und berufsübergreifende Lösungen bei Krankheitsbefunden und Pflegebedürftigkeit zu entwickeln sowie teamorientiert umzusetzen.“ (§5 Abs. 3 PflBG)
