Learning Outcomes

Academic competences

- Students will gain an in-depth understanding of key issues and problems in adult and continuing education, the discourse on lifelong learning, and professional practices in adult and continuing education.
- They will have an overview of selected areas of adult education (including general adult education, political and civil society adult education, vocational and in-company continuing education). They will be familiar with various forms of action in adult and continuing education and can reflect on issues and problems from a professional-theoretical perspective.
- Students can independently conduct (empirical) studies in adult and continuing education research according to scholarly and methodological criteria and classify the results in terms of their social impact on the field of adult and continuing education and their practical relevance to the profession.
- Students can critically classify ethics, sociality, and media education questions in the discourse on adult and continuing education.

Ability to take up professional employment

- Students have acquired academic knowledge they can critically assess regarding its relevance to adult and continuing education practice. They can shape the various fields of activity in adult and continuing education and justify their actions based on research findings.
- Students are exceptionally qualified for tasks in the international context of adult and continuing education. They have developed international networks and use these to support local initiatives in adult and continuing education.
- The programme enables students to independently pursue further study of current research findings in adult and continuing education.
- In addition, students learn about institutions and organisations in adult and continuing education and can contribute to organisational change processes.
- Students develop their own professional identities in adult education. The International Learning Project offers special opportunities for reflection.

Empowerment for civic engagement

- Students develop the willingness to contribute with their abilities to co-creative and participatory processes and to participate actively in democratic decision-making.
- Students acquire a broad knowledge of scholarly and social questions and issues. They can argue for their positions on an academic basis, take other positions into account in an appreciative manner, and contribute these to discursive formats in a dialogical manner.
- Students are qualified to engage in dialogue in the context of internationalisation and to communicate international perspectives.

Personal development

- Students will be able to work independently in an international environment.
- Students can work cooperatively with other individuals and groups by communicating different international perspectives.
- Students can draw conclusions based on the current state of research.

This module focuses on visitor-centred approaches to museum work. Based on the theoretical considerations of social inclusion (Richard Sandell), the opening of museums to all milieus and social groups (keyword diversity) as well as participative and self-reflective museum work are dealt with, but also the strategic development of target groups. Best practice examples will be discussed and ideas for your own implementation options developed. An additional focus is on current research in the sense of a theoretical foundation for museum practice.		
Intended learning outcomes		
Students are familiar with different theoretical approaches and methodologies and are able to put them into practice in museums. This transfer of practice and theory generates a gain in professional competences in addition to academic knowledge.

The module offers theory-based insights into the large, diverse area of "cultural heritage" - whereby aspects of identity formation, collective memory, history and cultural policy are also taken into account - and provides in-depth knowledge from various thematic sub-areas. There is a fundamental focus on the aspect of the creation of cultural heritage (heritagification) as well as the respective mechanisms, actors and interests behind it.		
Intended learning outcomes		
Students are able to recognise that "cultural heritage" is not something that exists per se, but something that has been created. They can critically reflect on who, at what time and for what reasons, has an interest in declaring a certain object as "cultural heritage" and in preserving, changing or destroying this "heritage".

This module focuses on visitor-centred educational/mediation (Vermittlung) work with digital media, which is becoming increasingly important in museums. Based on an expanded concept of education (cultural education/Kulturelle Bildung) and self-collected results of qualitative visitor research, new digital mediation formats are developed for selected museum objects in teamwork and design concepts are created. These are visualised using models. There is an additional focus on material culture with regard to qualitative object analyses and ways of use.		
Intended learning outcomes		
In addition to basic competences in model making, students have the ability to apply methods of visitor research and exhibition evaluation (contextual design, design thinking) and to evaluate the results. They have acquired reflective knowledge of target groups, mediation methods and the use of digital media in museums. The development of a realisable, digital mediation and design concept for a museum object in working groups strengthens discourse, team and professional skills.

In this module, students learn the basics of empirical research methods that are relevant for research in the field of adult education/continuing education. This includes basic principles of empirical research methods as well as the development of survey designs (e.g. interviews, questionnaire surveys), data preparation (e.g. transcription, data cleansing), data selection (e.g. working with existing data sets), the development of evaluation methods (e.g. interview analysis, descriptive statistics) and the understanding of empirical studies. Before booking courses, it is recommended to have the eligibility for recognition of the course confirmed via master-education@uni-wuerzburg.de.
